Stop5Ginternational & International Appeal to Stop 5G on Earth and in Space (5G Space Appeal)

- With regard to the status of the stop5ginternational group and the International Appeal to Stop 5G on Earth and in Space, there is no official connection between the two. As one of the two people who created the Appeal, I have a duty of care towards the signatories of the 5G Space Appeal. I was not consulted about any cooperation between these two entities, and nor have I consented to any cooperation between the two or endorsement of stop5ginternational by the 5G Space Appeal. Most significantly, to my knowledge none of the signatories has consented either. Consequently there has been both error of judgement and unethical conduct.
- A woman called Nicolya Christi became a member of the group organising stop5ginternational and aroused a great deal of controversy because she has very close ties to people associated with the eugenics agenda. After my protestations (and those of many others, I understand) and bringing forward of the evidence, she has now withdrawn from the group, or so she says. I have not received adequate replies to my questions, in particular about the funding of the stop5ginternational website, which may have been donated by Ms. Christi.
- This lack of judgement on the part of stop5ginternational leaves them vulnerable to questions about their trustworthiness, especially given that it took a great deal of time and many emails back and forth to convince them that this woman's participation would bring their group into disrepute. Even now, they appear not to have accepted it. In my view, given her questionable associations, she should never have been part of any stop 5G group in the first place. As soon as I saw her associates six months ago on first coming into contact with her, I had nothing further to do with her. Ten days ago I discovered that she had been embraced not only by the stop5ginternational group, but also by Arthur Firstenberg as administrator of the 5G Space Appeal.
- This problem is compounded by the fact that Arthur Firstenberg appears to have used the 5G Space Appeal list of signatories' email addresses to promote a questionable third party organisation. This is both unethical and may contravene privacy laws. I did not give my consent to this.
- In my view, neither instance is conduct of the standard required of those operating in the public domain and I have been forced to waste a great deal of time voicing my objections.

Message from Claire Edwards

Dear all

Stop5Ginternational & International Appeal to Stop 5G on Earth and in Space (5G Space Appeal)

Arthur Firstenberg has chosen to associate the International Appeal to Stop 5G on Earth and in Space with a dubious self-appointed group, stop5ginternational, which was infiltrated by someone closely associated with various people at the very top of the Club of Rome/Agenda 21/2030/"sustainable development" movement, which believes in top-down control of people and resources, and depopulation. This is contrary to the aims of the stop 5G movement. This woman is central to a worldwide movement whose objectives may not be in alignment with those seeking to stop 5G and her participation in the stop 5G movement may be motivated by a desire to attract people to her own cause.

I repeatedly asked who funded the stop5ginternational website and received no answer, which leaves the possibility open that this woman and/or her associates funded, and worse, may still be funding and hosting the stop5ginternational website. By choosing to associate with such people and rejecting transparency, stop5ginternational has chosen to sacrifice public trust. The fact that they decided to attack me rather than provide answers to legitimate questions is proof of their lack of good faith.

I warned Arthur Firstenberg several times not to embrace stop5ginternational because I would not give my consent to the Appeal or to the email addresses of signatories to the Appeal being used in support of a third-party organisation whose choice of associations, standard of conduct and lack of transparency bring it into disrepute. Arthur Firstenberg's deliberate choice to do so despite repeated and firm forewarning on my part has tainted the good standing of the International Appeal to Stop 5G on Earth and in Space.

As one of the authors, the editor and the designer of the Appeal, as well as the administrator of all its language versions, I spent the whole of 2019 campaigning on behalf of the Appeal at my own expense, while Arthur Firstenberg took complete control of the Appeal, the email addresses of the signatories and all donations, not a single cent of which he shared with me. His actions in unilaterally endorsing stop5ginternational despite my dissent are evidence that he considers the Appeal to be his personal fiefdom.

Henceforth my association with the Appeal to Stop 5G on Earth and in Space and with Arthur Firstenberg is terminated and I hereby withdraw my name as a signatory.

The Appeal remains factually accurate and fully referenced and may therefore continue to be used as a campaigning tool. However, I will no longer be campaigning on behalf of the Appeal as I cannot condone the unethical conduct of its administrator or the sacrifice of its neutrality.

I deeply regret my part in exposing many thousands of people already struggling with the horror of 5G to the further horror of this betrayal of trust. To find that I may have contributed to delivering the trust that people invested in me to the very eugenicists who are the authors of this 5G crime is a shocking discovery and a profound responsibility that will take me some time to process and recover from. I can only offer my deepest apologies for being the cause of additional harm and suffering at this time and ask your forgiveness for having participated in this unknowingly and having failed to prevent it.

Members of the public choosing to organise protests on 25 January may wish to decide whether or not they wish to do so under the aegis of stop5ginternational, or indeed any other self-appointed umbrella group. I regard stopping 5G as a personal responsibility and believe that it offers an opportunity for personal transformation. I do not believe in leadership or the need to provide guidance to autonomous individuals. I believe that individuals should act creatively, guided by their own best judgement, choosing whether or not they wish to collaborate with other individuals.

The perpetrators of 5G seek to collectivise opponents so that they can infiltrate groups and manipulate them, which is much easier than opposing millions of individuals acting creatively. I am receiving reports about infiltration and disruption in many groups in different countries, indicating that stop 5G campaigners would do well to beware of Greeks bearing gifts.

In 2019, the foundation was laid for our success and many innovative, creative and determined individuals across the world -- who are not members of organisations and have no affiliations whatsoever -- are right now planning concrete steps to ensure that 5G is halted in 2020. I wish all stop 5G campaigners everywhere energy, courage, determination, optimism and, above all, independence of mind and soul.

Dear Jan and Eduard

Co-option of the *International Appeal to Stop 5G on Earth and in Space* in order to collectivise and misdirect the stop 5G movement

I have severed my connection with the *International Appeal to Stop 5G on Earth and In Space* and withdrawn my name as a signatory, despite the fact that I am one of the authors, the sole editor, designer and administrator of all of the 30 language versions, and despite having devoted myself full time to promoting the Appeal throughout 2019. This is because Arthur Firstenberg, the administrator of the Appeal, has effectively merged the Appeal into stop5ginternational by endorsing it and becoming an executive member of it himself. I did not consent to this and explicitly told Arthur that the *Appeal* should *not* be associated with stop5ginternational because it has dubious ties and, during a ten-day exchange of emails, stop5ginternational refused to provide transparency about its funding, its backing and the hosting of its website.

A woman called Nicolya Christi infiltrated the stop 5G movement starting in June 2019. The timing coincided with the pushback of mainstream fake news launched across the world and singing from the same songbook as of May 2019. Her stated intention was – in her own words – to collectivise and lead the stop 5G movement via a "round table". She is the coordinator of the Worldshift movement, which was started by Ervin Laszlo, himself the leader of Club of Rome in Hungary and initiator of the Club of Budapest by agreement with Aurelio Peccei, founder of the Club of Rome. The Club of Budapest is the social engineering arm of Club of Rome. "The WorldShift Network was designated as being responsible for the international projects of the Club of Budapest as well as for the coordination of the National Clubs." In its own words, Worldshift states the following <https://goldenageofgaia.com/2011/01/23/worldshift20-declaration/>:

- "It is the **responsibility of the people to choose leadership that is knowledgeable and wise**"
- We base ourselves on the Club of Rome **Limits to Growth** in 1972
- "We need to **replace the obsolete notions of nation-states**"
- We **need a "whole-system shift"**
- "The **human community needs comprehensive structural reform**"
- "We **need to leave everything we know behind** in order to get to where we need to go."
- "**A systemic thorough reinvention of every aspect of humanity**"
- "We are at a point in time when the spiritual dimension must become paramount in issues of decision making."
- "All states should establish an office for the specific fulfillment of the Millennium Development Goals" [later morphed into Agenda 21/2030]
- "**Capital must be protected** as other property rights"
- A new bottom line must be established which incorporates the well-being of the environment and of people as part of the social bargain of **society as a limited liability entity.**"
- "We must implement a proper valuation of the natural world **independent of human interests**"
- "**National sovereignty must be balanced** with universal norms and values."
- "The human future and financial markets must be sustainable"
- We need a "Global Environment Economy"
- "We must ... partner one another **through the greatest social transformation ever known.**"

These statements smack of dictatorship and Maoist Cultural Revolution. Now we see the Red Guards of the Extinction Rebellion death cult and school students encouraged to start intergenerational warfare, supported explicitly by the Club of Rome in a statement dated 14 March 2019

(<https://www.clubofrome.org/wp-content/uploads/2019/03/Statement-in-Support-of-Global-Student-Climate-Protests.pdf>).

Nicolya Christi denied her association with Ervin Laszlo, Club of Budapest and another person at the centre of "sustainable development" (widely regarded as a euphemism for depopulation) in an email dated 31 December 2019. On her Worldshift website, she explicitly endorses Extinction Rebellion, Greta Thunberg and the enforcement of 50% wilderness areas on the earth by 2030.

There has been a great deal of covering up of the tracks of this infiltration through the deletion of the entire Ervin Laszlo website and many pages on the Worldshift website. No doubt in the light of this email there will be further deletions so I suggest to all those reading this email that they do not delay in doing their own research.

The members of stop5ginternational chose to attack and slander me instead of responding to reasonable requests for transparency and full disclosure. Arthur Firstenberg acted unethically by unilaterally aligning the *5G Space Appeal* with a third-party organisation choosing to bring itself into disrepute by associating with dubious agendas. Only these actors themselves know if they are naive, ignorant or corrupted.

The climate change agenda and the "science" of the International Panel on Climate Change have been challenged by over 1,000 scientists. The climate change scam was openly adopted as a Club of Rome ploy in order to manipulate populations into voting for their own demise ("The real enemy is humanity itself"). Greta Thunberg is a brain-damaged child set up as a global icon and Pied Piper. She has an eidetic memory, a Soros-funded handler and parents in the theatrical business.

5G is the end game of the depopulation agenda of Club of Rome, intended to depopulate the earth and usher in a total surveillance system as exists currently in China - where 13 million people have already been made non-persons - and a one-world, totalitarian government. The aims of the climate change agenda are identical. Espousing the fake climate change agenda death cult is antithetical to any genuine desire to stop the intended 5G population cull. Therefore the two movements must not be merged into one.

Everything in this email can be corroborated by Internet searches. None of this evidence is "conspiracy theory" (a meme created by the CIA in the 1960s to stop people questioning the absurdities of the Warren Commission report on the JFK assassination). It is conspiracy *fact*. Any future ad hominem attacks on me would be proof that the accusers are not interested in establishing the facts and cannot face the truth of their own naivety or delusion.

I encourage everyone to do their own research and make their own decisions. Collectivising the stop 5G movement plays into the hands of the perpetrators of 5G since it offers them the opportunity of misdirecting a global movement. It is vital that stop 5G groups and individuals across the world remain independent and autonomous and above all, unpredictable.

Given that the merger between stop5ginternational and the *5G Space Appeal* is now a fait accompli, registering one's data with either stop5ginternational and/or the *5G Space Appeal* could render those data vulnerable to retaliation. Only by overwhelming the perpetrators by force of numbers (of individuals) and original, creative

ideas to overturn their grip on power will we win. We are David. They are Goliath. Let us keep in mind who won!

Thank you very much for your initiative to organize the "Global-5G-Protest-Day"!

We, as an institutionalised European Initiative (ECI) called "Attention 5G", have already had the opportunity to get to know Claire Edwards personally and exchange information with her. This was at an international "Stop-5G"-Meeting on 29.06.2019 in Mendrisio/Switzerland, which was organized by Maurizio Martucci (Italy). There we had the privilege of introducing ourselves as ECI.

The ECI, founded in May 2019, is the right answer for activities in the area of EU member states with a concept of multi-track strategic action components. The legal framework is now being set by the governments of the EU-Member-States with joint resolutions in the European Union. Only by changing the legal framework at European level can we make a difference to an untested 4G-5G-6G roll-out. In Europe, we established national citizens' committees alongside a multinational European Citizens' Committee, which is registered with the European Commission. The application for registration with the EU Commission is currently being reviewed by an expert.

We will provide the infrastructure – an own website - for a international digital network (collaboration platform).
